A Accreditation Renewal Inspection visit is subsequently only required if after documentation review suggests there is a potential problem, or in the case of a serious complaint issued against the Institution suggesting it will no longer meet the standards for accreditation. Commissioners may also make random site visits to institutions that may raise red flag issues. Accreditation may be revoked only with due process.</p>
